B. Application

- 1. I understand and accept that in order to get admission to SARTHI's Digital Employability Enhancement Program (CSMS-DEEP), I need to complete pre-admission process comprising of completing the profile, shortlisting of Application by SARTHI Authority and payment of Security deposit.
- 2. I understand and accept that apart from educational eligibility criteria mentioned on the program website, shall have separate selection criteria of Age, Income, Caste, Caste Certificate and other requisite criteria stipulated by SARTHI.
- 3. I understand and accept that my application to this CSMS-DEEP scheme does not give any guarantee or any confirmation that I will get the confirmed admission for this CSMS-DEEP scheme. It is depending upon complying with various terms, conditions and/or situations as may be applicable from time to time.
- 4. I understand and accept that after submission of application through Center, concerned Authorities may or may not process my application. I will not have any objection against SARTHI/MKCL regarding the pendency or rejection of my application in any case.

C. Selection

I understand, accept and declare that

- 1. the admission form sent directly to the SARTHI will NOT be accepted.
- 2. the admission to SARTHI's Digital Employability Enhancement Program (CSMS-DEEP) may be granted only to those Applicants who have fulfilled requisite criteria within stipulated schedule.
- 3. the SARTHI and MKCL reserves the right of offering the SARTHI's Digital Employability Enhancement Program (CSMS-DEEP) on their own selection norms for the program, to any Applicant.
- 4. after approval of my application from SARTHI, the admission to SARTHI's Digital Employability Enhancement Program (CSMS-DEEP) shall be granted to all the selected candidates subject to their compliance with the eligibility criteria for the program and subject to availability of intake capacity at concerned Center.
- 5. after approval of my application from SARTHI, I will collect the receipt from Center regarding the Security Deposit paid to Center.
- 6. I will fill the Application Form physically and submit the signed copy of the same to Center.

D. Learning, Assessment

1. I understand and accept that I will be regular in studying CSMS-DEEP modules through the eLearning framework for which login shall be provided to me by MKCL, at mutually convenient timings agreed with the ALC offering program. Further, I understand that it is mandatory for me to complete the CSMS-DEEP modules, take interim performance tests,





submit assignments, activities etc. by following the prescribed schedule & guidelines published by MKCL / SARTHI from time to time on program website – https://sarthi-maharashtragov.in/ or https://sarthi-maharashtragov.in/ or https://sarthi-maharashtragov.in/ or <a href="https://sarthi-maharash

I undertake to be punctual and proactive in completing my learning and assessment activities and I shall be solely responsible to follow the communication being published on the website by MKCL / SARTHI from time to time.

- 2. I understand and accept that I will collect Module-I Book, Module-II Book from concerned center (within stipulated time) once learning of respective Module gets started and I will submit my book-acknowledgement to Center in this regard.
- 3. I understand and accept that I will mark my daily attendance (in-time and out-time) through Biometric device / IRIS recognition device on regular basis. I will also mark entry in physical attendance register (in-time and out-time) maintained at Center.
- 4. I understand and accept that I will complete the learning and examination of all the 4 Modules within stipulated time.
- 5. I understand and accept that if someone else completes the learning on behalf of me then my learning will not be considered and my candidature will be terminated. In such case, neither Security Deposit paid by me will be refunded nor Certificates will be issued.
- 6. I understand and accept that I will collect Module wise Certificate and CSMS-DEEP Diploma Certificate from concerned center (within stipulated schedule) once I will pass the final exam of respective Module and once respective Certificates will be released by SARTHI-MKCL. If I fail to collect final printed Certificate within 3 months, then SARTHI or MKCL or ALC will not responsible for any kind of loss.
- 7. I understand and accept that I will be regular in studying CSMS-DEEP modules at Center. Learning / Content will not be available in Online mode, I cannot learn from any other place.
- 8. I understand and accept that I will appear for the final examination of CSMS-DEEP modules only from the Center and not from any other place. Also, Final Examination will not be available in Online mode.
- 9. I understand and accept that if someone else complete the final examination on behalf of me then my exam score will not be considered and my candidature will be terminated. In such case, neither Security Deposit will be refunded nor Certificates will be issued.
- 10. I understand and accept that I will get maximum 3 Final Exam Attempts (within learner validity period of 12 months after the confirmation) per Module.
- 11. I understand and accept that the final examination will be conducted under surveillance of CCTV camera. Hence, learners Photo and Video will be captured by the camera throughout the exam period. E. Placement Assistance

- 1. I am aware that for SARTHI's Digital Employability Enhancement Program (CSMS-DEEP), MKCL (through ALC) may try to provide the placement assistance with at least 3 Interview chances. I also understand and acceptsthat, it is not the placement guarantee.
- 2. I also understand that, getting the placement is not my right under this CSMS-DEEP scheme. This is the additional facility extended by MKCL / SARTHI.
- 3. I also understand that, I will not have any specific choice for the particular employment / sector / salary package / location / industries / any other such conditions. I will try to participate in the placement activities for the options made available by SARTHI / MKCL with the help of Center.
- 4. I also understand that, I will try at my level to get placed or to get engaged in self-employment.
- 5. I also understand that, if I gets any offer letter from any company / organization / IP then it will be my responsibility to join or not to join.
 - a. If I will not join in the selected company / organization / IP then I will not get any further chance for placement activity from SARTHI / MKCL.
